#### 4. First aid measures

Clean surface thoroughly to remove residual contamination.</p> <p>Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Clean up spills immediately, observing precautions in Protective Equipment section. Sweep up and shovel into suitable containers for disposal.</p>
