## 6. Accidental release measures

**Methods and materials for containment and cleaning up**  
Soak up with inert absorbent material. Clean contaminated surface thoroughly.  
Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.  
Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination.  
Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Clean up spills immediately, observing precautions in Protective Equipment section. Sweep up and shovel into suitable containers for disposal.

**Environmental precautions** Avoid discharge into drains, water courses or onto the ground.
